A Pre-Application Review meeting is available at no charge to help you with your project submittal. Pre-Application Review meetings are attended by city staff representing various departments, for example, the Planning, Building, and Engineering Departments. All development permits and approvals require a pre-application conference with the Community and Economic Development Department prior to submittal of an application. The purpose of this conference is to discuss the nature of the proposed development, application and permit requirements, fees or deposits, and all applicable plans, policies and regulations as they relate to the project.
