

**SECOND AMENDMENT TO INTERLOCAL AGREEMENT
BETWEEN THE CITY OF NORTH BEND AND SI VIEW METROPOLITAN PARK
DISTRICT FOR DEVELOPMENT, MAINTENANCE, SCHEDULING AND
OPERATIONS OF TORGUSON PARK**

This Second Amendment is entered in this 22nd day of March, 2017 between the City of North Bend, a Washington municipal corporation (City) and Si View Metropolitan Park District, a Washington park district (District).

- A. The City and the District entered into an Interlocal Cooperation Agreement on January 1, 2016 (Torguson Agreement) with the District providing for the joint use, maintenance and operation and eventual joint ownership of certain City owned real estate commonly known as Torguson Park (Park) consistent with a Master Plan adopted by the City Council (Master Plan);
- B. The Torguson Agreement was amended by First Amendment dated April 20, 2016 providing for the District constructing a new BMX bike pumprack at the Park and the City contributing \$20,000 toward the design of the new BMX bike pumprack (First Amendment);
- C. King County has awarded a Youth Sports Facilities Grant to the City in the amount of \$200,000 to make certain improvements to the outfields at the Park and in reference to the BMX bike pumprack;
- D. The District wishes to continue to apply for grants in order to continue to make improvements to the Park consistent with the Master Plan;

NOW, THEREFORE, the parties agree as follows:

1. **King County Grant Funds.** Upon receipt of the Youth Sports Facilities Grant funds from King County in the amount of \$200,000, the City shall transfer such funds to the District and the District shall be solely responsible for using such funds for making the following improvements to the outfields at the Park:
 - Remove the existing surface plant material from outfields;
 - Rough grade the outfields to level and fill in low elevations;
 - Make an irrigation plan for the outfield grass areas using an existing City water mainline in the park as the point of connection;
 - Trench and install all mainline and lateral irrigation lines including valves, valve boxes, valve control wire, controller, and irrigation heads;
 - Place on the outfields a minimum of four inches of fairway sand;
 - Obtain a final grade of half a percent draining away from the infields;
 - Seed the new outfields; and
 - Once constructed, the District will maintain the improved fields at its expense.

2. Full Force and Effect. Except as amended by this Amendment, the Agreement shall remain in full force and effect.
