

RESOLUTION 1859

A RESOLUTION OF THE CITY OF NORTH BEND, WASHINGTON, ACCEPTING THE 2016 UV UNITS REPAIRS PROJECT AND AUTHORIZING THE RELEASE OF RETAINAGE

WHEREAS, the City owns and operates a Wastewater Treatment Plant (WWTP); and

WHEREAS, in 2016, staff and contractors found significant damage to several wires, failing wire connectors, inadequate cooling, and motherboards that were suspected of being on the verge of failure in both ultraviolet disinfection (UV) systems at the WWTP; and

WHEREAS, the UV systems are required to work 24 hours per day to sufficiently disinfect secondary wastewater effluent prior to discharge to the South Fork of the Snoqualmie River; and

WHEREAS, failure of the UV systems would result in inadequate treatment of the wastewater, leading to endangerment of the environment and public health and safety, as well as resulting in a violation of the City's NPDES permit; and

WHEREAS, the City Council deemed it necessary to repair the found deficiencies; and

WHEREAS, on January 19, 2016, the City Council declared an emergency, authorizing staff to effect the necessary repairs; and

WHEREAS, staff executed a work order with Keithly Electric on January 20, 2016 in the amount of \$10,345.50, including taxes to perform the work; and

WHEREAS, Keithly Electric performed the work between the dates of January 13, 2016 and January 14, 2016; and

WHEREAS, the work was satisfactorily completed on January 14, 2016 at a total cost of \$10,345.50, including taxes; and

WHEREAS, the City must accept the projects prior to submitting for releases from the State Department of Revenue, Department of Labor and Industries, and the Employment Security Department for the retainage of the contractors;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH BEND,
WASHINGTON, DOES HEREBY RESOLVE AS FOLLOWS:**

Section 1. The City of North Bend accepts the Keithly Electric work on the 2016 UV Units Repairs Project.

Section 2. The City of North Bend authorizes the release of the retainage on the contract upon receipt of the appropriate clearances from the appropriate agencies of the State of Washington.
