

RESOLUTION 1890

A RESOLUTION OF THE CITY OF NORTH BEND, WASHINGTON, RENAMING CERTAIN STREETS IN THE STILSON AVE SE AND EAGLES NEST PL SE AREA

WHEREAS, the City of North Bend (City) has the authority to enact and maintain a uniform system of naming streets pursuant to RCW 58.17.280 and 35A.11.020; and

WHEREAS, the City is authorized to rename existing streets by way of City Engineer recommendation and City Council resolution per North Bend Municipal Code Section 12.12.050; and

WHEREAS, several annexations have resulted in several east/west oriented roads both public and private with names based on the King County street grid system; and

WHEREAS, the King County street naming grid system does not match with the City's street grid system; and

WHEREAS, the City, Eastside Fire and Rescue, and the North Bend/Snoqualmie Police Department strive for consistent addressing for efficient emergency response for the health and safety of City residents; and

WHEREAS, City Ordinance 1300 gives precedent and guidance to recommended street names used in this resolution; and

WHEREAS, the City Engineer recommends the address changes proposed within this resolution;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH BEND, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The following King County named streets and addresses in the Stilson Ave SE and Eagles Nest PL SE areas are renamed as follows:
