

AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN THE CITIES OF ISSAQUAH, SNOQUALMIE AND NORTH BEND FOR POLICE DISPATCH AND RECORDS MANAGEMENT SERVICES.

THIS AMENDMENT amends that certain Interlocal Agreement between the Cities of Issaquah, Snoqualmie, and North Bend for Police Dispatch and Records Management Services (the “Interlocal Agreement”) entered into by the parties on March 25, 2014.

WHEREAS, the Interlocal Agreement sets forth the terms and conditions under which the City of Issaquah has agreed to provide police dispatch and records management services to the cities of Snoqualmie and North Bend, and

WHEREAS, Section 16 of the Interlocal Agreement provides for an initial five-year term ending March 8, 2019 and for automatic renewal thereafter for successive five-year terms unless terminated under Section 18, and

WHEREAS, the parties desire to renew the Interlocal Agreement and to amend Sections 2.7 and 2.8 of the Interlocal Agreement to recognize that the start-up costs provided for in Section 2.7 have been paid and to reduce the automatic annual price escalator provided in Section 2.8 from 5% to 3%.

NOW, THEREFORE, the parties have entered into this Amendment under the terms and conditions set forth below.

1. Start-Up Costs. In recognition of the fact that the start-up costs provided for in Section 2.7 of the Interlocal Agreement were paid in full, Section 2.7 is hereby deleted and of no further force and effect.

2. Automatic Price Escalator. Section 2.8 of the Interlocal Agreement is revised to read as follows:

2.8 PSAP and RMS Cost. Issaquah will continue to provide the Services in 2019 for the sum of \$519,822. The price will increase by 3% on January 1, 2020 to \$535,416. For each calendar year thereafter, the sum will increase by 3%, resulting in the following payments amounts during the years 2021 through 2024: 2021 - \$551,478, 2022 - \$568,022, 2023 - \$585,062, and 2024 - \$602,613. If this Agreement is renewed for an additional five-year term or terms after 2024, the total sum will continue to be increased by 3% on January 1 of each calendar year thereafter unless otherwise agreed to by the parties. Amounts paid by Snoqualmie for PSAP and RMS Services under this Section shall be the entire amount paid by Snoqualmie for the Services.


3. Other Provisions. Except as expressly amended by this Amendment, all provisions of the Interlocal Agreement remain in full force and effect.
