

# ORDINANCE 1745

## AN ORDINANCE OF THE CITY OF NORTH BEND, WASHINGTON, AMENDING THE CITY'S 2021- 2022 BUDGET AND SALARY SCHEDULE ORDINANCE NO. 1737; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE

**WHEREAS**, the City Council adopted the City's 2021-2022 Budget and 2021 Salary Schedule pursuant to Ordinance No. 1737 on December 1, 2020; and

**WHEREAS**, the City is prohibited from over expending its appropriated budget as set forth in Ordinance No. 1737; and

**WHEREAS**, certain revisions to the 2021 budget are now necessary; and

**WHEREAS**, the City Council now desires to amend the 2021 Salary Schedule to adjust the Deputy Finance Director salary range, adjust the PW Operations Manager position, and add the position and salary range for the GIS Analyst and Accounting Operations Manager;

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH BEND, WASHINGTON, DO HEREBY ORDAIN AS FOLLOWS:**

**Section 1.** The 2021 Budget, as adopted in Ordinance No. 1737, is hereby amended as set forth in Exhibit "A".

**Section 2.** The explanations of the amendments are listed in Exhibit "B".

**Section 3.** The 2021 Salary Schedule is hereby amended as set forth in Exhibit "C".

**Section 4. Severability.** Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

**Section 5. Effective Date.** This ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.
