

# **RESOLUTION 2007**

## **A RESOLUTION OF THE CITY OF NORTH BEND, WASHINGTON, SUPPORTING THE EXECUTION OF POLICIES INTENDED TO ENSURE THAT MOBILITY AND MOBILITY INFRASTRUCTURE ARE ACCESSIBLE, AFFORDABLE, CONVENIENT, COORDINATED, RELIABLE AND SAFE FOR SNOQUALMIE VALLEY RESIDENTS, BUSINESSES, AND VISITORS**

**WHEREAS**, since 2017, the Snoqualmie Valley Mobility Coalition (SVMC), a network of transportation providers, city staff and officials, human services organizations, and community advocates, has been working to improve transportation and mobility options; and

**WHEREAS**, when mobility priorities and equity practices are considered, it is known that mobility encompasses all modes of transportation, including public transit, biking, pedestrian walking and rolling options; and

**WHEREAS**, mobility policies should to the extent financially and otherwise feasible ensure accessible, affordable, convenient, coordinated, reliable, and safe mobility options and infrastructure; and

**WHEREAS**, when planning new developments and projects or improving current developments and projects, these policies may be considered to lead to standard practice and implementation throughout the Snoqualmie Valley; and

**WHEREAS**, when new roads, new developments, or other new projects are planned, the City Council encourages appropriate coordination and collaboration with other applicable agencies to consider and include mobility priorities; and

**WHEREAS**, the adoption of this resolution by the North Bend City Council is one component of a coordinated effort by the Snoqualmie Valley Mobility Coalition for cooperation among the Snoqualmie Valley cities for cooperation on mobility options and infrastructure; and

**WHEREAS**, the City of North Bend understands and appreciates the importance of mobility for the community and the Snoqualmie Valley;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH BEND,  
WASHINGTON, DOES HEREBY RESOLVE AS FOLLOWS:**

**Section 1. Authorization.** The City of North Bend supports the coordination among Snoqualmie Valley cities of safe mobility options and infrastructure for residents, businesses, and visitors.
